WRIGHTINGTON PARISH COUNCIL

At the Meeting of the Parish Council of the Parish of Wrightington held on Monday 19 July 2010 at Appley Bridge Village Hall at 7:30 pm the following were present:

Councillors: Mr F Hodgkinson (Chairman), Mrs J Burton, Mr J Clinch, and Mr I McRae.

OPEN FORUM

(At this point in the Meeting members of the public present can report, ask questions, raise issues and make observations on parish matters or items appearing on the Agenda. Reports will also be received from the Police, District and County Councillors if attending – Once open forum is closed the Chairman will only suspend standing orders to allow public participation in extreme circumstances.)

<u>Public Present</u> – Residents were present from Church Lane and reported on activity, giving them cause for concern, at 4A Church Lane. The Clerk had obtained information confirming that Inspire Children's Services have placed a young person, with a carer, at this address. Concerns relating to swearing and a young resident alone on Church Lane late at night, could relate to the previous placement however, concern was expressed about the lack of communication and interaction with the young person currently living at this address and the local community. Residents do not believe this is the right environment and are concerned for the young lady's welfare and the amount of time she spends in the garage, staring out the window. Residents were informed that if they have any serious concerns they can report them under the Child Protection Act. There has obviously been a lack of communication with the residents. Planning – Appley Bridge Football Club were initially unaware of the requirement to apply for planning permission to vary the conditions of the existing permission. The variation is for a one-off annual event, for use of the toilet facilities. It is hoped that the Parish Council will support this variation. Reports - Could not report any progress yet on the possible bus shelter in-front of Mossfields. There are still numerous large pot-holes on Mossy Lea Road requiring attention. It has been suggested that a bandstand could be part of the refurbishments on Mossy Lea playing field. Residents thanked the Parish Council and Borough Councillor Gartside for their help with the installation of drop kerbs at Mossfields however, vehicles are parking across them and on the corner of the cul-de-sac. Councillor Mrs Burton agreed to pursue this matter. Grass is still growing in the gutters at the kerb edges. The public footpath signs on Tunley Lane, near the bridge, and at Carr House Lane, still require re-setting. Questionnaires relating to the play provision on Mossy Lea playing field will be circulated and the information returned will be collated to establish specific requirements at the site. The edges of the carriageway on Church Lane are eroding away near the Church and the chevrons on the bend have been damaged again. Activity at Martin House Farm, is outside the Parish however, the Parish Council will ask the neighbouring planning authority to ensure the public right of way through the site is retained during and after work is completed. It is hoped that Computer courses at Mossy Lea Village Hall will commence late September.

- 27. APOLOGIES Were received and accepted from Councillors Mrs Rees (holidays), Mr Taylor (Acting on the advice of the Police to remain at home following a recent incident compromising his personal safety The Clerk reported that Councillor Taylor had planned to be present to report on all the work he has undertaken over the past couple of months, as the Parish Councils web co-ordinator, on the Parish Council website, renewing, updating and improving the site and its content.). Apologies were also received from Borough Councillor Gartside.
- **28. DECLARATIONS OF INTEREST** Members were asked to consider any personal/prejudicial interest they may have to disclose in relation to matters under discussion at the Meeting. There were no declarations at this point in the meeting.
- **29. MINUTES** The Minutes of the Meeting of the Parish Council held on Monday 21 June 2010 had been circulated in advance of the Meeting and were accepted as a correct record and signed by the Chairman.
- **30.** CASUAL VACANCY The Clerk reported that there had been no request for an election and therefore the Parish Council could now co-opt to fill the vacancy. Two applications have been received, from Mr Frank Johnson and Mrs Pamela Baybutt, both were read aloud. Following discussions it was proposed, seconded and RESOLVED: THAT MR JOHNSON BE APPOINTED TO THE VACANT POSITION. MR JOHNSON ACCEPTED THE

APPOINTMENT, SIGNED HIS DECLARATION OF ACCEPTANCE OF OFFICE TAKING UP HIS POSITION AS PARISH COUNCILLOR, MOSSY LEA WARD, WITH IMMEDIATE EFFECT, JOINING PARISH COUNCILLORS FOR THE REMAINDER OF THE MEETING.

31. UPDATE/PROGRESS WITH ISSUES RAISED AT THE PREVIOUS MEETING – The Clerk reported Councillor Mrs Rees's email and her opinion that, the fact mobile telephones must be off or on silent during meetings has affected the manner in which Parish Council business is conducted. Some points were disputed by those present but, the contents were noted.

36. VILLAGE HALLS

<u>MOSSY LEA</u> – Painting and improvements to the toilets will be part of funding bids from the Community Chest or LAG fund, whichever is the most suitable – Electrical Inspections are due, the necessary arrangements will be made – Cancer Research UK attending Coffee Morning 6 August 2010 to collect second cheque. PAT Testing will be arranged over the summer.

<u>APPLEY BRIDGE</u> – RESOLVED: To purchase a new urn/hot water boiler, the pensioners will be contributing towards the cost if their funding bid is successful – Electrical Inspections are due, the necessary arrangements will be made – PAT Testing will be arranged over the summer. Professional advice is required from a structural engineer before proceeding with any funding bids to remove the false ceiling in the hall and kitchen, professional drawings may also be required. Councillor Mrs Burton has met with the Insurance Company, pursuing matters as necessary. Information about Appley Bridge, pre 1939, will be reproduced and framed for displaying in the Village Hall and on the website. The secure room is now ready for use, shelves erected and locks fitted.

Hire agreement forms need re-drafting and standardising to cover both village halls, hiring and indemnity.
