WRIGHTINGTON PARISH COUNCIL

At the Meeting of the Parish Council of the Parish of Wrightington held on Monday 19 September 2011 at Appley Bridge Village Hall at 7:30 pm the following were present:

Councillors: Mr F Hodgkinson (Chairman), Mrs J Burton, Mr F Johnson and Mr J Clinch. Also present Borough Councillor Gartside.

OPEN FORUM

(At this point in the Meeting members of the public present can report, ask questions, raise issues and make observations on parish matters or items appearing on the Agenda. Reports will also be received from the Police, District and County Councillors if attending – Once open forum is closed the Chairman will only suspend standing orders to allow public participation in extreme circumstances.)

<u>Member of the Public</u>: Double yellow lines at the junction Hinds Head Avenue/Mossy Lea Road are cracked and a trip hazard. There is still a piece of wood on the footway in front of 259 Mossy Lea Road. Hedges are overgrown in front of 261 Mossy Lea Road. The site of the electricity substation adjacent to Ainscoughs, Wrightington, is in a very untidy state. Pot holes on Mossfields car park have been very poorly filled and some still need attention. The carriageway at the kerb edge near 265A, B and C Mossy Lea Road, is breaking up and dangerous. Grass verges and hedges on Broadhurst Lane are overgrown and severely narrowing the carriageway. Cars parked on Tunley URC car park, Hinds Head Avenue and Manse Avenue, have been damaged and broken into, with items stolen. 2 windows are still broken in the telephone kiosk on Mossy Lea Road. Savilles have been undertaking a housing stock survey for West Lancs. BC. Some homes have substandard kitchens, central heating systems and double glazing with some gas fires being obsolete. The Council will ask Borough Councillors Mrs Baybutt and Mr Garside to pursue these matters directly with the Borough Council. Borough Councillor Gartside agreed to investigate enquiries relating to height of fences and hedges.

52. **HIGHWAYS AND ENVIRONMENTAL MATTERS**

- 1) Flooding continues on Mossy Lea Road near the Village Hall and No's 5 & 11. Gullies are also blocked with straw and grass.
- 2) The Mossy Lea Road sign, opposite the Tunley Lane junction, needs re-attaching to the post.
- 3) Grass and weeds are growing in the road channels and overgrown hedges are restricting access to the road channels for the road sweeper.
- 4) The area around the Mossy Lea Road/Crow Orchard Road junction, near the BP and Bluebird garages is very untidy, with branches left by contractors lying in the grass.
- 5) Illegal signs and diverted route at Footpath No. 5 require attention. Signs indicate that the definitive route is boggy.
- 6) The definitive route of the public footpath at Hesketh House Farm is now completely blocked.
- 7) Public Footpath 21, Moss Lane to Mossy Lea Road, is un-walk able in places.
- 8) Stakes are still in the grass verges on Appley Lane North, Appley Bridge.
- 9) A recent incident on a footway and public right of way, where a dog knocked over a child the person involved was referred to Legislation relating to dogs on leads from West Lancs. BC.
- **REPORTS FROM REPRESENTATIVES ON OUTSIDE BODIES** Councillor Clinch 53. attended a Peter Lathom Charity Meeting and reported that money can now be distributed within the Parish.
