WRIGHTINGTON PARISH COUNCIL

At the Meeting of the Parish Council of the Parish of Wrightington held on Monday 21 November 2011 at Appley Bridge Village Hall at 7:30 pm the following were present:

Councillors: Mr F Hodgkinson (Chairman), Mrs J Burton, and Mr I McRae. Also present Borough Councillors Gartside and Mrs Baybutt and County Councillor Ms Evans.

OPEN FORUM

(At this point in the Meeting members of the public present can report, ask questions, raise issues and make observations on parish matters or items appearing on the Agenda. Reports will also be received from the Police, District and County Councillors if attending – Once open forum is closed the Chairman will only suspend standing orders to allow public participation in extreme circumstances.)

Borough Councillor Baybutt: Reported that the estates management team at West Lancs. BC are discussing with the residents the possibility of removing the grass in front of the flats at Mossfields to address parking problems. This will involve installing drop kerbs and strengthening works to protect the utilities running under the footways. Residents have been given a grant application form for completion. This has been cost prohibitive in the past. The Parish Council are still happy to contribute to this by undertaking a topographical survey of the land. West Lancs. BC and LCC are working together on this matter. Parking provision could be tarmac, grass screed or individual bollards. Confirmed that the attendance at the recent Remembrance Day Service was excellent. Regarding a request to add names to the war memorial, if this is considered it must be ensured that all names are added so as not to cause offence. Cleaning the stone was also raised. Regarding stakes in the grass verge on Appley Lane South, on LCC highway, these are dangerous. Complaints regarding obstruction of site lines at Robin Hood Lane/Hall Lane junction by A-boards on the pavement have been reported as has the overhanging vegetation over the footway at Bank Brow, Appley Bridge. LCC officers will be asked to attend. County Councillor Evans: Reported double yellow lines will be installed on Hall Lane, either side of the hospital entrance. The railings erected on Appley Lane South will be replaced soon, failure to consult with the residents has lead to this, at a considerable cost to LCC (approx. £10,000). Councillor Ms Evans will forward a copy of the secondary gritting routes for circulation to Parish Councillors. Councillor Ms Evans agreed to report a deep ditch on Tunley Lane, just past Tunley Farm on the left hand side, which is quite deep and dangerous.

- 75. APOLOGIES Apologies were received from Councillors Johnson (Bereavement), Clinch (Illness) and Page (Prior Commitment). Councillor Page commented that the Remembrance Day Service was well organised and well attended and thanks to all who helped and participated.
