WRIGHTINGTON PARISH COUNCIL

At the Meeting of the Council of the Parish of Wrightington held on Monday 17 September 2012 at Mossy Lea Village Hall at 7.30pm the following were present:

Councillors: Mrs Burton (Chairman), Mr J Clinch, Mr F Johnson, Mrs D Hanlon and Mr I McRae. Also present Borough Councillor Mrs Baybutt and Borough/County Councillor Ms Evans.

OPEN FORUM

(At this point in the Meeting members of the public present can report, ask questions, raise issues and make observations on parish matters or items appearing on the Agenda. Reports will also be received from the Police, District and County Councillors if attending – Once open forum is closed the Chairman will only suspend standing orders to allow public participation in extreme circumstances.)

<u>County Councillor Ms Evans</u> – Reported on the LCC Capital Programme of works for 2013/14 and details of a Mossy Lea Road flood mitigation project to address drainage issues near Raby Fold Farm and, resurfacing of Whittle Fold Lane, Courage Low Lane, Toogood Lane and Moss Lane with surface dressing to Bannister Lane and Robin Hood Lane and a horizon scheme for Appley Lane South being looked at. Pavements will be attended to on Church Lane and patching and surface dressing will be undertaken on Finch Lane. Residents parking at Mossfields will be included for 2013/14. Councillor Ms Evans has been in contact with the Environment Agency, the Highways Agency and United Utilities to discuss flood risk aspects and observations/objections which could influence planning decisions. It was reported that no Parish Representative attended the recent Three Tier Forum Meeting.

<u>Borough Councillor Mrs Baybutt</u> – Has raised hedgerow and environment issues with Andrew Burrows, LCC. Flooding remains a problem on Toogood Lane and water is still coming through the tarmac on the footways. The drains were pumped out but this did not resolve the problem. The water flowing down both sides of the carriageway on Toogood Lane will be lethal in winter. It was reported that the blocked drain on Moss Lane, causing flooding problems on Courage Low Lane, was cleaned out but is now blocked again and the junction will be very dangerous if the problem continues into the freezing weather. Councillor Mrs Baybutt requested specific planning objections to the application for a wind turbine at Stoneleach Farm in order to successfully call in the application for consideration by the Planning Committee. Mrs Burton confirmed submission of objections on behalf of the British Horse Society as the turbine would be too close the riding track and would discriminate against riders with epilepsy. The issues of damage to wildlife habitats and the necessity for a bat and bird survey were also raised. The Parish Council still believe an environmental impact statement should be required and that risk assessment from a health and safety point of views should be taken into account. Serious concerns remain about opening the floodgates for further applications and the cumulative effect of more applications in the future.

<u>Public Present</u> – Councillor Johnson reported that a number of drainage, pot-hole and highway issues have been discussed with LCC Officers, including the inadequate pipe and culvert at the edge of the playing field adjacent to Mossy Lea Village Hall. The stop-tap cover near street light No.187, Mossy Lea Road, has sunk. A motorist visiting a Mossfields resident was told that she could not park on the car park by another resident. The large rhododendron bushes on Robin Hood Lane need cutting back, stakes in the grass verge on Appley Lane North still need removing, boulders at Harrock Hill continue to give cause for concern and the entrance to the car park at Mossfields needs significant cutting back and clearing.

THE PARISH COUNCIL RESPONSE TO THE ABOVE IS: THEY OBJECT TO THESE PROPOSALS ON THE GROUNDS THAT AN ACCESS ROAD TO THE PROPOSED DEVELOPMENTS AT SOUTH TUNLEY FARM FROM MOSSY LEA ROAD WILL HAVE A DETRIMENTAL IMPACT ON THE VISUAL AMENITY, AND WILL UNACCEPTABLY ALTER THE EXISTING STREET SCENE, OF MOSSY LEA ROAD. THE PROPOSED ACCESS ROUTE HAS ALWAYS HAD AN HISTORIC MULTI-PURPOSE USE BY PEDESTRIANS, JOGGERS, CYCLISTS, HORSERIDERS AND PEOPLE WITH PRAMS WHOSE PERSONAL SAFETY WILL BE SEVERELY COMPROMISED BY THE VEHICULAR ACTIVITY ASSOCIATED WITH THE DEVELOPMENT OF ADDITIONAL DWELLINGS AT SOUTH TUNLEY FARM. THE ROUTE COULD BECOME A RAT-RUN FOR PEOPLE WISHING TO CUT ACROSS FROM MOSSY LEA ROAD TO TUNLEY LANE WITHOUT USING THE MOSSY LEA ROAD/TUNLEY LANE JUNCTION WHICH ALSO THEREFORE RAISES THE ISSUE OF POLICING THE ROUTE. THE ACCESS ONTO MOSSY LEA ROAD WILL COMPROMISE HIGHWAY SAFETY FOR VEHICLES EXITING ONTO MOSSY LEA ROAD AND FOR MOTORISTS USING MOSSY LEA ROAD, BOTH OF WHOM MAY BE UNABLE TO ADEQUATELY VIEW SITELINES. THE COUNCIL BELIEVE THE FOOTPATH SHOULD BE UPGRADED TO A BRIDLEWAY THEREBY PROTECTING AND CONFIRMING ITS HISTORIC USE AS A TRACK OR LANE FOR THE PAST 60+ YEARS BY LOCAL RESIDENTS. THE UPGRADING WOULD ALSO PROVIDE A VALUABLE PARISH AMENITY FOR USE BY WALKERS, CYCLISTS, HORSE RIDERS AND, A SAFE ROUTE FOR PARENTS AND CHILDREN ATTENDING THE LOCAL SCHOOLS.

SCHEDULE 1

2012/0569/FUL – Installation of one small scale 11 kw Gaia wind turbine, mounted on a free standing 18m high lattice mast on a 5m2 concrete base. The turbine is twin bladed with a blade diameter of 13m. Stoneleach Farm, 7 Toogood Lane, Wrightington.

Taking account of the large number of objections expressed by the parishioners of Wrightington, and the relevant Planning Policies, the Parish Council **strongly object** to this planning application on the grounds that the proposals would contravene a number of national and local planning policies.

The proposals would constitute inappropriate development within the Green Belt, in accordance with Planning Policy DS2, which prevents such development unless very special circumstances can be demonstrated. The Parish Council believe that the applicants Design Statement does not demonstrate sufficient benefits to the environment and the community to outweigh the detriments associated with granting permission for the wind turbine and therefore, does not demonstrate the special circumstances required for such a development in Green Belt. It is a fact that many renewable energy projects, when located in the Green Belt, will be considered inappropriate development. These proposals would have a serious detrimental impact on the openness of the Green Belt, and result in a significant loss of visual amenity for the residents, the community and the Parish as a whole.

The scale, appearance and visual impact of these column type structures would have a significant adverse impact on the skyline and the rural nature of the area and, would be completely out of character with the existing street scene resulting in a visually intrusive blot on the landscape. The presence of the wind turbine would detrimentally affect the amenity and quality of life of local residents. Residents homes would also be closer to the structures than the 'Distances to Resident's Homes' Bill, currently in progress in the House of Lords, would permit.

The installation of wind turbines in the Green Belt constitutes a significant development and should require community consultation and the commissioning of a full and complete independent Environmental Impact Assessment taking account of all relevant legislation, planning policy, the views of the local authority and the views of the local community who would have to live with the environmental impact of the proposals in the long term.

The Parish Council do not consider that the environmental benefits associated with energy production from this renewable source outweigh the detriments to the wider environment of Wrightington. Account should be taken of the recent High Court Judgement which concluded that the right of local villagers to preserve their landscape was more important than the Government's renewable energy targets. There will be no social or economic benefit to the community, no jobs will be created and, any reduction in the farms carbon footprint and any "greening" of the local environment would be minimal. National Planning Policy Statement 1 states that "the planning policy system operates in the public interest to ensure the development and use of land results in better places for people to live, the delivery of development where communities need it, as well as the protection and enhancement of the natural and historic environment and the countryside". These proposals would ruin the beautiful landscape of Wrightington, described by West Lancashire Borough Council as an Area of Landscape History of County Importance, rather than resulting in a better place to live. To minimise the impact of developments the Borough Council advise that proposals should avoid uncharacteristic or visually intrusive development, should avoid interference with long distance views from high points accessible to the public and should avoid the introduction of tall columnar constructions. The proposals would therefore contravene Borough Council policies. The development is neither wanted nor needed and would benefit no-one else in the community only the applicant.

The proposals would detract from the natural and visual amenity of the countryside and would seriously affect wildlife and their habitat. The current database held by Lancashire Environment Record Network lists numerous locations close to this site where bats, and their roosts, are present and therefore to ensure that adequate account is taken of biodiversity and to comply with planning policy it is imperative that a Bat Survey is undertaken prior to any development of this nature. There are also owls, herons, curlews, and lapwings present in the vicinity whose habitat and daily activity would be impacted by the proposals. Minutes – Wrightington Parish Council Page 6 of 7 The proposed site of the wind turbine would impact on public footpath users accessing the public rights of way running either side of the proposed location of the turbine and also the riding track in this vicinity. Therefore, the Council believe that a full Health Impact Assessment should be conducted to assess the health and wellbeing implications associated with the noise, vibration and flicker/strobe effects produced by the wind turbine. A site specific Noise Survey should be undertaken as research indicates that the noise produced by wind turbines is constant, monotonous and, as well as being heard when in close proximity to the turbines, also carries some considerable distance and would therefore affect homes and residents on Courage Low Lane, Toogood Lane and Tunley Lane, as well as further afield. Research also indicates that vibration and the flicker/strobe effect produced can result in an increased incidence of headaches, migraines, nausea, dizziness, sleep disorders, stress and anxiety. These proposals would also discriminate against epilepsy sufferers as it is a recognised fact that the flicker/strobe effect can be extremely debilitating and can actually induce an epileptic seizure in sufferers. It is also possible that the horses could be startled by the flicker/strobe effect caused by the moving blades causing accidents/ incidents which could result in injury or harm to both horse and/or riders using the riding track. Therefore, it is essential that a site specific Health Impact Assessment and a Health & Safety Risk Assessment is undertaken.

The West Lancashire Local Plan 2012-2027, currently under consultation, contains a Policy, EN1, directly detailing the proposed criteria for Wind Energy Development and stating that account must be taken of:- singular or cumulative impacts on landscape character and value, the impact on local residents (including flicker noise and shadow flicker), the ecological impact including migration routes of protected bird species, impacts on land resources including agricultural land, impacts on the historic environment and assets, community benefits and, impacts on aviation navigation systems and communications.

The Planning Committee should ensure that they are not responsible for setting a precedent by granting planning permission for the wind turbine and thus opening the floodgates for further similar applications in the Parish which could ultimately be in contravention of the terms of the West Lancashire Local Plan 2012-2027 and the Distances to Resident's Homes Bill.
